## North Dakota 1-D Barcode Specifications

The North Dakota Tax Department currently utilizes a scanning/imaging solution to process tax returns and payment vouchers. This document provides tax preparation software developers requirements for developing barcodes for computer generated substitute tax forms.

#### **Specifications:**

- 2 of 5 Interleave
- Barcode Dimensions minimum <sup>3</sup>/<sub>8</sub>" x 1 <sup>1</sup>/<sub>4</sub>"
- Print barcode numbers directly below the barcode
- 1-D barcodes are required on all forms listed in the appendix and must follow the form specifications for proper placement on the form. Additional sample forms not listed in this document may have barcodes on them but they are *not* required.
- If you purchase forms from another vendor: Use your <u>NACTP ID</u> in the barcode or where otherwise required. Print the form developer's number any place where there is sufficient room.
- When creating the Estimated Payment Vouchers, the barcode must be the same for all four vouchers even if they are printed on multiple pages.

The following two sections designate the specific format for each form that contains a 1-D barcode:

### I. Forms designed on a 6x10 grid:

Barcodes for these forms should be in the following format: 6 or 8 characters - MMYYIDNN

- Month revised used only for those forms based on revision date.
- Tax Year 2 characters (YY)
- $\circ$  Form ID 2 characters (ID) See Appendix for form codes
- $\circ$  Page Number (NN)
- See form layouts on <u>developer website</u> for exact value of barcode.

### II. Forms not using the 6x10 grid:

Barcodes for these forms should be in the following format: 12 characters - MMYYID9999NN

- Form Revision Month 2 characters (MM) See Appendix for revision dates
- Tax Year OR Form Revision Year 2 characters (YY)
- $\circ$  Form ID 2 characters (ID) See Appendix for form codes
- NACTP ID 4 characters (9999) See <u>NACTP website</u>
- $\circ$  Page Number (NN)
- All revision dates are given in the appendix.
